Cannonsnap Ridge is a diverse 40 acre recreational or homestead property located a few miles south of Cameron in Milam County, TX. This unique ranch features a seasonal creek, large post oaks, and a clear hilltop homesite with a view. The paved frontage and electric gate at the entrance make this ranch feel like home with easy access, no restrictions, and endless possibilities.

This property is a perfect 40-acre model of the Texas post oak savannah. Half of the property sits atop a gentle bluff and slopes westward towards a seasonal creek. With over 50 feet of elevation change from the homesite on the ridge to the creek, the sunset views are outstanding.

The property is dotted with post oaks, hackberry, live oak, and plum. Deferred grazing has resulted in a beautiful carpet of wildflowers and other beneficial grass and forb species. American beautyberry, sparce prickly pear, and dewberry comprise the mid-story. The soil is a well-drained sandy loam, perfect for grazing cattle and horses or continued wildlife management. Electricity on-site. Perimeter fenced.

The property is currently qualified under the wildlife tax exemption with estimated taxes of \$168.44.


